14. 3 adult's 2 children 16' open boat engine failure at the Anderson Ferry towed boat to Constance Marina.

**Campbell County**

15. 2 adult's bayliner boat adrift, out of fuel at 459.6 towed boat to safety
16. 2 adult's 28' engine failure at 466.5, towed boat to safety
17. Life Threatening 2 adult's 19' boat adrift mid stream, Cincinnati/Newport area out of fuel, tow boat/ barge approaching secured boat and passengers, towed boat to safety
